

Publicly Available Data

DataArts offers downloadable sets of aggregated data at no cost. Datasets will be updated regularly. Visit our website culturaldata.org to download aggregated data.

Aggregated Data

"Aggregated data" includes summary statistics that do not identify individual organizations and are calculated by combining data from multiple organizations grouped by specific geography (states, counties, zip codes) or other parameters (disciplines, budget sizes, etc.). Most frequently, these are provided as data tables or charts with calculations performed by DataArts research staff.

Any individual or organization may request aggregated data by submitting a Data Use Application and paying applicable data preparation fees. A rate of \$85 per hour will apply, with a \$200 minimum charge per request.

Disaggregated Data

"Disaggregated data" is a dataset comprised of organizational data from individual Cultural Data Profiles. Each Data Profile contains data from one Fiscal Year from one organization and contains up to 1400 data points. This data is provided for research purposes only. Any public work products making use of DataArts data must report findings in aggregate and may not identify or attribute individualized data to any individually identifiable organization.


Data Use Applications for disaggregated data must be submitted by those seeking data for research purposes. Applications will be reviewed and approved or declined by DataArts staff. Approval will be based on the project's clearly defined goals, intentions, and audiences; the user's prior research experience; and/or qualifications in relation to the proposed project. Once a request is approved, the user will receive disaggregated data after i) paying all applicable data processing fees (see Schedule of Fees below), and ii) signing a Data License Agreement which outlines requirements for data security, citation requirements, etc. DataArts holds all researchers accountable for using DataArts data with integrity and with respect for the work of all the organizations that have completed Cultural Data Profiles.

Schedule of Fees for Disaggregated Data

In addition, for more detailed requests (e.g. those involving specific disciplines or more specific sets of organizations) additional data preparation and processing fees of \$85/hour may be applied.

Masked Data

Masked data is a type of disaggregated data from which variables that can be used to identify a particular organization have been removed (e.g. name, address, EIN). Data may be masked at the behest of the individual or organization making the request, or as required by DataArts. Fees as in "Schedule of Fees for Disaggregated Data" (above).

Fees may be waived for educators or graduate students requesting a masked dataset for educational, classroom-use-only purposes or for dissertation research.
